Please address this matter.	i) Define whole Scope of Work for all functions and subfunctions in broader terms and the TORs for subsequent phases. ii) TOR for SRS preparation will be including but not limited to this phase presented in relevant section about it. iii) TORs for Software Development and/or Implementation will be related to this phase, which will use SRS developed in previous phase. Separation of all these is mandatory so that FEB & GIF may opt later for any of options as under independently. i) Preparation of SRS & Tendering for ERP development/Implementation OR selection/Implementation of off-the-shelf ERP separately based on SRS prepared.  OR ii) Preparation of SRS & development/implementation of ERP OR Selection/Implementation of some off-the-shelf ERP.
